### Re-enrollment

Currently enrolled families are offered the opportunity to re-enroll their children before new families are accepted in the spring of each year. At that time, Little Ones Montessori families are required to pay a non-refundable Registration Fee of \$200 to secure placement for the next academic year. Siblings are given priority to enroll after completion of the admissions process and payment of the Registration Fee for first time enrollment.

Families who do not meet their tuition obligations due to nonpayment are not eligible to reenroll until said balance is paid in full plus the accruing interest as per the Tuition Agreement.

### Tuition Payment Policy

Tuition is due on the **20<sup>th</sup> of the month in advance** of services. The academic year begins August 24<sup>th</sup> so tuition for the month of September is due August 20<sup>th</sup>. Subsequent months follow suit. A non-refundable Registration Fee of \$200 or place holding fee is payable at the time of enrollment. **A late fee of \$35.00 is charged each time a payment is received after the 1<sup>st</sup> of the month for which service is provided.**

### Refund Policy

Enrollment obligates parents to pay a full year's tuition for the 180 day academic year. Places are reserved for children for the entire academic year and **no deductions in tuition are made for absences, holidays, withdrawal or dismissal**. If, however, a child is dismissed during the two week trial period, tuition will be based on attendance. If a child remains in school past the two trial weeks, full tuition for the academic year is due as agreed upon.

**Note:** Registration Fees are due by March 1, 2010 for each child enrolling. Materials Fees are due by June 1, 2010 for each child enrolling.

### PAYMENT PLANS

There are two payment plans that you may choose from:

#### Plan A

You may deduct 5% from the total balance of the academic calendar tuition if payment is made in full by June 1, 2010. See Tuition Payment Schedule. Sibling Discount is not available with this plan.

#### Plan B

Ten monthly payments electronically paid through FACTS on the due date. All fees incurred for this option are paid by parents.

Sibling Discount: Automatic deduction will reflect a discount each month according to the Tuition Payment Schedule for an enrolled younger sibling in any full day program. Siblings enrolled in half day programs do not qualify for a sibling discount.

## Tuition Agreement 2010 - 2011

### Little Ones Montessori Policies Regarding Tuition

Initial each item to confirm.

- \_\_\_ All Fees are *nonrefundable*.
- \_\_\_ Enrollment obligates parents to payment of Tuition for the school year.
- \_\_\_ New students are accepted with an initial two week trial period.
- \_\_\_ A **service charge of \$35.00** is charged on payments made more than 15 days late or **after the 1<sup>st</sup> of the month** for which tuition was to be applied (i.e. If payment for September is received after September 1<sup>st</sup>, a late fee applies) and interest at the rate of 18% per annum shall be charged from the date on which the payment was due until the payment has been received.
- \_\_\_ A \$35.00 charge will be applied for insufficient funds.
- \_\_\_ Children will be denied admittance to school if payments are more than 20 days late (on the **5<sup>th</sup> of the month** for which payment was to be applied).
- \_\_\_ Should Little Ones Montessori incur attorney fees, court costs or other expenses in connection with an effort to collect any sums due for tuition, or other obligation, the school shall be entitled to collect such reasonable attorney fees, court costs, and other allowable expenses.
- \_\_\_ If participating in VPK ONLY, tuition is reimbursed by the state. If, however, the child attends **at any time** beyond VPK ONLY hours, the parent is responsible for the Registration Fee and Materials Fee, as well as any fees incurred according to the Tuition Fee Schedule.
- \_\_\_ **All parents agree to participate** in snack rotation.
- \_\_\_ If an early drop off or late pick up fee is applied **5 times or more in one month**, tuition will be automatically collected at the appropriate rate commensurate with the program.
- \_\_\_ Parents agree to pay all fees charged by FACTS for the 10 month payment option.
- \_\_\_ All parents agree to the Parent Plan for Participation and to participate for the required number of hours or agree to pay the assessed fees.
